

Dear Parent/Carer,

We are sure that you are all aware, that in the current climate, we need to be very mindful of a range of circumstances that we may encounter during the coming school year, which may result in the necessity for online or remote learning.

In line with DfE guidance, we have carefully planned our learning provision based on different possible scenarios.



Plans for this blended (home/school) approach to learning, rely on good ICT access and connections. If families are unable to access online provision, we will ensure hard copies of work are provided and we will make arrangements for appropriate feedback.

We have already started to make sure that all children are very familiar with all of our home learning platforms so that we can switch to home learning as quickly as may be required.

We are committed to safeguarding our pupils and we teach pupils about safeguarding, including online safety, through various teaching and learning opportunities as part of a broad and balanced curriculum. Google Meet is the only permissible live platform used to support blended learning in school (including whole school assembly and Collective Worship opportunities).

All feedback and communication with pupils will take place through online learning platforms or from school google email addresses.
